Pickup & Transportation: Buyer is responsible for pickup and transportation from the ACID yard located on Barney Street in Anderson, CA.

• If ACID staff assists with loading and/or delivery, you will be billed directly on a time and materials basis.

TERMS AND CONDITION OF SALE

Returned Checks: In the event a check is returned due to insufficient funds, account closure, or any other reason, the following policy applies to all purchases of pipe:

- 1. Returned Check Fee: \$35.00 returned check fee will be assessed for each returned check.
- 2. Payment Reversal: Any deposit or payment made by check that is returned will be considered unpaid until the full amount, including the returned check fee, is resolved.
- 3. Replacement Payment: Customers must submit a replacement payment in the form of a:
 - Money Order

- Or other certified funds

Personal checks will not be accepted as replacement payment for a returned check.

- 4. Order Status: Orders associated with a returned check will be placed on hold until payment is resolved. If payment is not received within 5 business days, the order may be canceled, and pipe inventory will be released to the next customer in line.
- 5. Future Orders: Customers with a history of returned checks may be required to pay in full with certified funds for future orders.

Pickup Deadline & Deposit Forfeiture: Customers must pick up their purchased pipe within three (3) months from the date of order. If the pipe is not picked up within this timeframe, the order may be considered abandoned, and the 50% deposit may be forfeited. Prior to forfeiture, the Anderson-Cottonwood Irrigation District will make reasonable efforts to contact the customer using the information provided on the application.
